Dear Senator Patrick Leahy:

I am writing to you in regards to your position of Congressional Oversight and your role in Congressional investigation and evaluation of problems and issues of the performance of the FBI. The purpose of this letter is to express concern about the Federal Bureau of Investigation's (FBI) response, or lack thereof, to problems in its disciplinary system and whistleblower retaliation.

I currently need your assistance (prior to 2/15/07) to prevent the destruction of evidence in regards to the retaliation I received as a whistleblower against the FBI's mishandling of the 9/11 and Anthrax investigations. I am currently trying to get an investigation of direct interference in my employment at the Pinnacle Career Institute in Lawrence Kansas. This interference in my employment occurred after I pressed for an investigation of the direct personal intimidation and threats leveled at me for providing information. The FBI and the WA DOH put me through a hostile situation to discredit me as a witness and whistleblower. I wish to be able to fully provide details of my interaction with Special Agent John O'Neill prior to his death but the FBI seems intent on silencing me. Their efforts to discredit me have so impacted my life that I have been forced to take charity to survive. I believe that military intelligence, DEA and the CIA may have a

different opinion of the value of the information I offered to the FBI. I recently have had a CIA attorney take my sworn testimony as a deposition over a secure line.

For almost 2 decades I provided information regarding security concerns to FBI Special Agent John O'Neill that is relevant to the terrorist attacks of September 11, 2001, and the subsequent Anthrax attack. I had originally quietly provided information to the FBI, but the Bureau responded by deliberately retaliating against me and discrediting me with a campaign of false information. As a Cooperating Source of Information, instead of an appropriate response to my concerns, I was placed in direct physical danger, poisoned with the drug GHB, and serially raped by criminal elements tied to corruption within the FBI. As I was personally attacked physically, emotionally and psychologically, I attempted to discern the reason for this aggressive and abusive response of the FBI to the intelligence I wished to supply them.

There was a clear lack of respect for intelligence information by the FBI prior to 9/11 and definite cover-up of mistakes in their handling of intelligence assets and criminal/terrorist informants. FBI Special Agent John O'Neill and I ran into criminal corruption which influenced the response of the New York, Boston, Seattle and Sacramento FBI field Offices. I believe that FBI Special Agent Nancy Floyd of the New York Office may be able to give you a perspective of the environment within the NY FBI office prior to 9/11 and the Anthrax attacks. She was involved in recruiting Emad Salem but was then not properly supported by the FBI management in the NY field office in order to be able to effectively use the information he supplied.

It is my firm belief that Sacramento FBI Special Agent John Zent endangered National Security through his mishandling of terrorist informant Ali Mohammed. I believe that Ali Mohammed was behind an attempt to obtain both Nuclear materials from Hanford Nuclear Reactor and Biological Agents from Battelle Northwest in 1987-1998. I also believe that FBI SA John Zent was personally involved with the criminal drug network in California (Dana Ewell). Special Agent Zent did not prevent his informant, Ali

Mohammed, and others from generating income for terrorist activities through drug operations in California.

While in Tulare, CA as a USDA veterinarian, I found a firmly entrenched network of corruption which protected the criminal drug operations in California. In attempting after 9/11 to give information to the FBI, I spoke to Fresno FBI Special Agent John Gliata in 2003. I also had contact with Senator Diane Feinstein, (Senate Select Committee on Intelligence) and Senator Lynch (House of Representatives Governmental Reform Committee). I participated with a "sting" operation which netted a "high level security suspect" but then no one prosecuted the perpetrator and the violence against me continued. I was immediately hit with fabricated allegations against my character and efforts to permanently destroy my professional career and personal reputation. It drove me out of my position as a veterinarian on the USDA TB Task Force in Tulare CA.

In 2003 while living in Tulare, CA and working as a USDA Veterinary Medical Officer, I also had contact with Investigative Journalist Gary Webb and Fresno Sheriff's Department Detective Aaron Kilmer (working under cover). The threats and violence that occurred after that contact, led to what I believe, were the murders of FBI Task Force Officer, Aaron Kilmer in Aug 2003 (officially an motorcycle accident – but maybe a GHB poisoning) and Journalist Gary Webb (officially a suicide but a double tap to the head). I believe that these deaths are to cover-up a money laundering operation tied to 2 methamphetamine labs in California associated with a Moroccan Hawala operation which was supplying terrorist funding. This money laundering operation was linked to a former BCCI account previously frozen by European law enforcement but released prior to the 9/11 attack. Shadrack Manyathella was the listed main signatory on the bank account which was originally in Isle of Mann but transferred to a British Channel Island Account with a branch bank in London. There were two other silent signatories on the account who were both listed on the Golden Chain List as financiers of terrorism. The African cell associated with Shadrack Manyathella in Carabou, Maine was obtaining \$30,000 in funds from the account right before 9/11.

In 2002 in Tukwila WA, I had direct contact with the Moroccan woman Crystina who did Hawala money transfers and money laundering. Crystina was living with Brooke Lorraine Webber in a hotel in Tukwila right after 9/11. Crystina did Hawala money transfers for the African Muslim community in Seattle, Oregon and California. In 2001-2002 Brooke Lorraine Webber was living with Crystina and Crystina's two young children, Fatima and Mohammed. Brooke Lorraine Webber was a former foster daughter of mine who had lived with me in 1993 for several months and re-contacted me in 2000. After leaving my home in 1993 but while still a minor in Vermont SRS Foster Care elsewhere, Brooke Lorraine Webber had a child, Elexa, from her sexual relationship with a South African man, Shadrack Manyathella. In 2001 I was told by Special Agent John O'Neill that Shadrack was a terrorist suspect. I found out later Shadrack was associated with TWH and Ali Mohammed. In 2001 Brooke wanted me to meet Shadrack and his associates. These terrorist suspects were interested in being in contact with my friends, Barbara and John O'Brien. Mrs. Barbara O'Brien worked at Batelle Northwest and Mr. O'Brien worked at Hanford Nuclear Reservation. FBI Special Agent John O'Neill's concerns were about efforts to acquire Nuclear or Biological materials. Batelle Northwest did DOD research and kept Fort Dietrich Strain Anthrax. Barbara and John O'Brien had been personal references for my husband and I when we applied to be Vermont State Foster/Adoptive parents to Brooke Lorraine Webber in 1993. The Vermont SRS Social Worker took background information from the O'Briens which she placed in the SRS file. But we found out to our dismay this confidential information about the O'Briens was inappropriately leaked in 1993 to criminals in Brooke's biological family. There was criminal involvement of SRS officials in covering up the sexual exploitation of children by these criminals. This ultimately led to the exploitation of foster girls and the murder of 16 year old Vermont SRS Foster child Christal Jean Jones in Jan 2001.

In 2001 prior to 9/11 FBI Special Agent John O'Neill had wanted a FISA wiretap and a sting operation to catch Shadrack Manyathella and those involved with the terrorist activities and money laundering. In early 2001 I consented as an American citizen to a FISA wiretap in sworn testimony over the phone to John O'Neill and two attorneys.

I am not trained in intelligence methods nor have any training in law enforcement. I am instead a Doctor of Veterinary Medicine. But as a DVM I was trained in the epidemiological investigation of Anthrax and other Foreign Diseases.

In 1987 I was a graduate student at Washington State University in Pullman WA. I was studying Neuroscience under Dr. Robert Speth in the Veterinary Department VCAP. My research project was on Angiotension, a hormone with direct effects on the brain and systemic blood pressure. I took advanced training in neuroscience, neuropharmacology and neuroanatomy, which was more extensive than that offered to the Doctor of Veterinary Medicine students who pursued only a clinical DVM degree.

In 1987 I was also active in my Quaker Meeting in Moscow Idaho and as such involved with a group of Muslim Women who were advocating women's rights in the Muslim community. The issue of domestic violence and the silence of the Muslim community in regards to severe repression of the rights of Muslim Women was a hot issue of discussion. I had direct personal contact with Muslim women from both the Pullman Washington and Moscow Idaho mosques. Most of these Muslim women were associated with the University of Idaho or the Washington State University. I also taught as a Free University Instructor, English as a Second Language to Arabic speaking students from Iraq and other Muslim countries.

In 1987 I was covertly approached by Muslim women in my women's group regarding the actions of a man who was trying to recruit young men for Jihad and to obtain money for Jihad and WAMY. One Muslim woman who was married to one of the students in my English as a Second Language class, risked her own safety to covertly pass me a written note and refer me to an elder at the Pullman mosque who was in high level discussions with the Mosque elders regarding this man's behavior. The Moscow mosque had permitted the man to speak without limitations. The Pullman mosque being located in an academic community tries to serve all persons of Muslim faith both Shiite and Sunni.

It was a political issue within the mosque not just for the women but also for the Muslim men.

This suspicious man also tried to get access to information about the O'Briens from myself and my husband, John Parker, by crashing my English as a Second Language class and showing up at my home unannounced. I reported his suspicious activities to the University Officials and then was contacted by the FBI. I cooperated with the FBI to obtain photographs of the suspect and was told that he was on the "watch list". My friend John O'Neill was only a FBI field agent at the time and his supervisors did not want to further investigate the matter. John O'Neill however was alarmed by the information that I had supplied him. He and I both knew that this suspect was attempting to get access to information regarding not only security at the Washington State University but also Hanford Nuclear Reservation and Batelle Northwest. FBI Special Agent John O'Neill and I believed this to be a significant threat to National Security. But the FBI refused to pursue the matter further and John's supervisor ordered John O'Neill to "drop it".

I remained in intermittent contact with FBI SA John O'Neill who went on to pursue a Masters Degree in Forensics. He occasionally would call to touch base and chat mostly about his forensics training and sometimes to ask about technical questions. I had unlimited access to a data base mining program on technical information, Dialog. As a friend, I would occasionally assist him with technical information retrieval. None of this was security related but instead was just routine technical material publicly and freely available. I had routine and easy access to medical information as a graduate student in the Veterinary School and spent many hours doing library research.

In 1991 I graduated with my degree in Veterinary Medicine. I moved to the east coast and attempted to address the difficulties in my marriage to John Parker. SA John O'Neill was in contact with me and congratulated me on my graduation. He had also successfully completed his studies for his Masters in Forensics. He had also started to work with the Washington Office of the FBI.

In 1993 in conjunction with a forensic investigation of the first Twin Towers attack, John O'Neill contacted me in an effort to find a "Person of Interest" - a Muslim woman who was possibly associated with the Roxbury mosque and whose family believed that she might be in danger because of a domestic violence situation. I tried to make some discrete inquiries even though I was not still active with my Muslim women's group. I unfortunately found the Muslim community to be very guarded and sometimes openly hostile and I withdrew my contact. I informed John O'Neill that I would not be able to help him.

The situation with the O'Brien family had worsened. Mary Jo O'Brien had married a man, Bill Wheeler, whose family had criminal connections. Mary Jo had been living in Oklahoma with Bill Wheeler, married him and had 3 children.. Mary Jo was in a domestic violence situation and attempted several times to flee. Her parents, Mr. and Mrs. John O'Brien attempted to help her. At one point in Oklahoma, Bill Wheeler and the criminals he was associated with, kidnapped the children and threatened to kill them. Mary Jo was terrified and in an effort to get her children back was placed in a criminally compromising situation and then blackmailed. Throughout the tumultuous marriage, Bill Wheeler used his criminal connections to control and dominate Mary Jo. I was becoming increasing alarmed at what I saw as a security risk to both Mr. and Mrs. O'Brien's safety. At one point Bill Wheeler came with a gun to Mr. O'Brien's home and threatened to shoot him. Bill Wheeler also played Russian roulette with a loaded gun to heads of Mary Jo's children and intimidated her with his violence. She learned as many women who are victims of domestic violence do, that it is safer to give in to the demands of her ex-husband.

In 1998 I moved to the Seattle area and re-established my contact with Mary Jo O'Brien/Wheeler/Sarver. Bill Wheeler and Mary Jo were going through a divorce and she was under constant threats by him. Bill Wheeler in an effort to find out what she was telling other family members was illegally wire tapping family members including the family home in Richland WA owned by Mr. and Mrs. John O'Brien. Bill Wheeler also

threatened me and Linda O'Brien (Johnnie O'Brien's wife). I was subjected to violent phone threats, surveillance and illegal wire taps. The situation was clearly a risk to National Security as Bill Wheeler was funneling information obtained from such illegal wiretaps directly to a criminal network.

Then Bill Wheeler was accused of involvement in a drug facilitated sexual assault. He showed up at Mary Jo's home in Everett with the police hot on his trail and told her that she had to perjure herself and give testimony that would give him an alibi for the rape. But I was visiting Mary Jo that very day at the very time Bill Wheeler wanted to pretend that he was with his ex-wife. I refused to lie to the police and Bill Wheeler threatened me and threw me out of house. Alarmed about the increasing violence and aware that there was a class A felony involved, I ran to the Seattle WA FBI field office to try to tell them that the escalating violence in the O'Brien family was possibly affecting the security of Mr. and Mrs. O'Brien as well as obstructing justice in a rape investigation. The Seattle FBI agents refused to take any action and didn't even write down my complaint, referring me instead to go to the local police. At this point I did not know what police department would actually be investigating the rape, so I called the Everett District Attorney's office instead. The Everett DA apparently did get a hold of FBI SA John O'Neill and realized that there was a larger issue involved rather than just a local rape. The Everett DA called me on a secure line and confirmed my status as an in place security informant source for the O'Briens. He told me that he would be investigating the matter further. Then I saw in the local newspaper that the Everett DA was murdered (shot twice in the head).

Receiving increasing violent threats over the phone and concerned for my personal safety, I decided to limit my contact with Mary Jo O'Brien. I informed Mrs. Barbara O'Brien that I increasingly concerned about Bill Wheeler's intimidation and influence over her daughter, Mary Jo. I also informed Barbara O'Brien that her granddaughter, Barbara Anne (only 16 years old at the time) had confessed to me her concerns for personal safety. Only months later, Barbara Anne came forward to testify that she had been raped by a family acquaintance. Barbara Anne was then forced to recant the rape allegations through family pressure and coerced to drop the criminal charges.

At this point I was contacted by FBI SA John O'Neill who was going to be in Seattle for an investigation. He was anxious that I use my contacts to help him. I was frightened that any contact with John would perhaps be picked up by the criminals who had been threatening me over the phone. He tried to make contact without a security net. My fears were not unjustified as I was immediately threatened by two black men in the stairwell of my apartment building right after his phone call to me. Fearful for John's own safety as well as my own, I felt the safest thing was to not make any contact and thus not put him at risk.

John O'Neill did not want to take NO as an answer and pressured me to meet with him even as he was boarding the plane to leave Seattle. SA O'Neill believed that the criminals were using connections to Bill Wheeler to try to get closer to secure facilities and restricted materials. I told John that I had cut off all connections with the O'Briens because of Bill Wheeler's threats. John felt that it was possible to design a way to catch the criminals. I was upset with the lack of FBI protection, frightened for my own safety and not willing to get any further involved with his investigation. We had a huge disagreement about the situation.

In late 2000 John O'Neill eventually persuaded me to help him but he had apparently less success convincing the FBI management. He was essentially threatened, compromised by his detractors and then forced out of the FBI. In 2001 SA O'Neill still felt fervently that there was going to be an eminent terrorist attack. He asked me to continue to be available to him after he left the FBI. He was planning to put his concerns in front of Congress and was trying to acquire the physical and documentary evidence that would convince a member of Congress of the urgency.
