You realize the 'stigma' of being labeled with a mental health issue.. I know how I struggled to get the help I needed to address my Bi-polar disorder.. I now enjoy the rewards of better personal relationship with my daughters, and grandchildren.. It's worth the effort because I know how trying to manage my stress and pain, by self medicating with alcohol (a cops go to drug of choice) nearly destroyed me.. Tell me, with your experience that you have not witnessed this countless times..
