I am very glad to hear that you are recovering from serious injuries from your bicycle accident.. I have enclosed an emergency kit for your future endeavors.. It contains a set of bicycle training wheels (they can flip up when doing your big boy riding).. Also; there is a get well card; with large band aid, and a small amount of medical marijuana for relaxing your muscles, and addressing the pain related to inflammation of joints and muscles.. Sorry, that I couldn't send more, but cost was prohibitive.. Also, I need the effects of this harm reducing medicine to enable me to function.. Not that your interested, but I was very seriously injured in the line of duty in 1984.. Injuries and surgery prevented me from the duties of a first responder.. I had never smoked marijuana as a youth, but with a continued use of an unlimited supply of opiates, and alcohol for pain management, someone advised me to smoke reefer.. I was unsure about it, until I used it.. It treated the causes of inflammation, and reduced the pain significantly.. In short: It worked.. I spoke with my doctor, John Frymoyer, the dean of medicine at UVM, and asked about the use and side effects of marijuana.. He advised me, that he couldn't even talk to me about pot because, " I'm afraid of the federal government".. I was a police officer disabled in the line of duty, and I couldn't even talk to my surgeon in the privacy of the doctor/patient confidentiality.. Then: I became an activist.. Not only did it help manage pain; and range of motion, it effectively helped me stop a long standing addiction to alcohol, (haven't drank in over 20 years), and even more importantly, the treatment of the synergy of alcohol and long term depression.. My evidence is found in the bettering of my personal relationships with my daughters..

I understand the 'Blue Wall of Silence' never allows the open discussion of law enforcement officers facing human difficulties.. For we never show 'weakness'.. that's simply beyond us.. But even a cursory view shows officers; stealing drugs from the evidence locker, and giving it to friends that are in need of the medical support that simply isn't available.. Note the number of robberies that are totally drug related by persons unable to get into rehab programs.. That policy seriously effects the public good..
